Advocacy, Education, and Grassroots Action. We engage on land-use issues that pose the greatest potential for critical gains or losses for open space, farmlands, natural systems, and wildlife habitat. We educate decision-makers and candidates for office to encourage them to champion and adhere to environmental policies. We mobilize people to take action on open space issues and navigate the political process, providing expertise and support on environmental issues local communities care about. This fiscal year we 1) saved 260 acres from sprawl, 2) monitored, commented, and advocated on 34 land use issues, and 3) won 4 ballot measure campaigns. Some of our most significant accomplishments include: 1) we successfully campaigned for Measure T in San Jose which generates \$50 million for the protection of Coyote Valley, San Jose, (continued on Schedule O)

Community Advocates Leadership Academy. Our Community Advocates Leadership Academy program trains a diverse community of changemakers across the public, private, and nonprofit sectors to more effectively advocate to protect open space and the natural environment. In 2018, we graduated 38 local changemakers from the Community Advocates Leadership Academy growing our alumni community to nearly 200.
