We achieve this by: 1) Engaging in local land use issues: Our staff engages early in land use policy, proposals, & planning processes, conducting thorough research to provide science-based recommendations. 2) Holding decision-makers accountable: We provide the support and information needed for our region's leaders to be champions for the natural environment and open space protection. 3) Empowering community members: We mobilize people and help them navigate decision-making processes. This year 2,179 acres of open space, farmland, and natural resources were protected or positively impacted...Continued on Schedule O

Community Advocates Leadership Academy. In 2020, we launched a reimagined Community Advocates Leadership Academy with a cohort of 20 local change makers. The training program and associated 230 strong alumni program now includes a robust focus on race equity in addition to augmenting environmental advocacy skills and knowledge to cultivate an even more powerful force for environmental justice in Santa Clara and San Mateo Counties. In 2020, our program was enhanced by the inclusion of its first director.
