Advocacy: Green Foothills champions the protection of nature, wildlife, and people in San Mateo, Santa Clara, and San Benito Counties through advocacy, education, and grassroots action. Our goal is to ensure that local land use decisions support open space, biodiversity, and sustainability. We achieve this by influencing decision-making on land use policy and proposals to better promote climate resilience and biodiversity. We provide the support and information needed for current and future decision-makers to be champions for conservation, and we leverage diverse partnerships to support smart and inclusive climate solutions. In 2025, our vocal and steadfast opposition to a plan for increased development along the Monterey Road corridor in Coyote Valley persuaded the City of San Jose to abandon that plan. Because Monterey Road runs alongside Coyote Creek—the backbone of Coyote Valley’s wildlife corridor—development in this area would have severely disrupted the safe movement of wildlife between the two mountain ranges, so this was a key victory. Our advocacy also led to permanent protection of 412 acres of farmland in and near the City of Gilroy when the Santa Clara County Open Space Authority acquired a conservation easement that keeps the land in agricultural use and prevents future development. One of the largest remaining working farms in the unincorporated area of San Martin, the land provides a scenic and environmental buffer, preserving open space and helping maintain a greenbelt between the growing cities of Morgan Hill and Gilroy. Our mobilization of community members in response to several sprawl development projects proposed under the “builder’s remedy” law resulted in the Santa Clara County Planning Commission rejecting the developers’ appeals; this was an important victory because the projects would have paved rural open space, increased greenhouse gas emissions, and put residents at greater risk of flooding, wildfire, and landslides. 2025 impact metrics: Our advocates engaged on 25 land use issues in

This year marked our 12th cohort and the third year we offered the program tuition-free and in Spanish and English, thanks to generous support from donors. The program builds community leader capacity that harnesses the power of collaboration within communities and mobilizes change agents to advance equitable, inclusive environmental activism locally. The Program aims to create pathways for people from all backgrounds to engage in and lead conservation work to help broaden representation in the local conservation movement. Leadership Program alumni 1) assume leadership roles where they apply a lens of environmental advocacy and cultural humility in their work; 2) initiate and join successful campaigns that advance Green Foothills's mission and vision; and 3) are involved in the Green Foothills community. 2025 impact metrics: 22 local changemakers graduated (including 2 Spanish speakers) for a total of 300 alumni since 2014. 31 alumni took on new leadership roles for a total of 168 since 2014, and 13 initiatives were won by alumni for a total of 74 initiatives since 2014. In 2025, Green Foothills's advocacy staff continued to partner with the Amah Mutsun to protect Juristac - the sacred heart of their ancestral territory - from a proposed open-pit sand and gravel mine,

and again provided \$3,000 in sponsorships to Calpulli Tonalehqueh, an Aztec dance group, for their Mexica New Year event. We also consulted with our Tribal and Indigenous Partners about their evolving needs, incorporating their feedback into our new 2025-2030 Green Foothills Strategic Plan Partnership Pillar. This is the first Green Foothills Strategic Plan to recognize (1) the importance of building authentic relationships with local tribes and Indigenous groups, and (2) that Indigenous peoples are foundational guardians of the land, carrying centuries of ecological wisdom that scientific approaches have often overlooked. The goals of the Pillar are to: Support and partner with local tribes to advance Indigenous land stewardship, including access to and ownership of ancestral lands and restoration of culturally significant landscapes. Build capacity among Indigenous partner tribes and organizations to effectively advocate for the permanent protection of their ancestral lands and engage in restoration and stewardship efforts.
